COUNTY OF SACRAMENTO

FIRST AMENDMENT TO AGREEMENT FOR CONSULTANT SERVICES WITH BRANN AND ASSOCIATES, LLC AND THE PUBLIC STRATEGIES GROUP, INC.

THIS FIRST AMENDMENT is made and entered into this 31st day of January, 2006, by and between the COUNTY OF SACRAMENTO, a political subdivision of the State of California, hereinafter referred to as "COUNTY", and Brann and Associates, LLC and The Public Strategies Group, Inc.(PSG), hereinafter referred to as "CONTRACTOR".

RECITALS

WHEREAS, the COUNTY and CONTRACTOR have previously entered into an agreement on April 5, 2005, which was approved by the County of Sacramento Board of Supervisors by Resolution No. 2005-0412, for the provision of a programmatic review of the Sheriff's Department (hereinafter "Agreement"); and

WHEREAS, COUNTY and CONTRACTOR desire to formally amend said Agreement to include an assessment of recent allegations of the mistreatment of those in custody in county jail facilities; and

WHEREAS, COUNTY intends to increase the Maximum Total Payment amount by \$206,843, from \$385,895 to a maximum of \$592,738;

NOW, THEREFORE, the Agreement is amended as follows:

I. <u>SCOPE OF SERVICES</u>

The Scope of Services is amended to include Exhibit A, including the current practices and recent improvements in the handling, processing, and treatment of those in custody, relevant and historical data, surveys, interviewing key stakeholders and interest groups, role and mission of the Sheriff's Citizen Advisory Board, inspection reports, and best practices regarding jail oversight. This proposal is hereby attached as Exhibit A and made a part of this Agreement.

Joseph Brann and Associates, LLC is entirely responsible for the additional scope of work.

II. COMPENSATION AND MAXIMUM PAYMENT TO CONTRACTOR

Contractors and subcontractors shall be compensated at the rates approved in the original contract. Subcontractors listed in Exhibit C of the first amendment shall be at the rate specified in the Exhibit. The Maximum Total Payment under this agreement is \$592,738. This proposal is hereby attached as Exhibit B and made a part of this Agreement.

Billings and payment for the First Amendment shall be with Joseph Brann & Associates, LLC, in accordance with Exhibit D.

III. <u>REAFFIRMATION</u>

In all other respects, the above referenced Agreement, as amended, remains in full force and effect.

IV. ENTIRE AGREEMENT

This Agreement, as amended, and any attachments hereto, constitute the entire understanding between the COUNTY and CONTRACTOR concerning the subject matter contained herein.

The entire agreement consists of: (1) the agreement between the parties originally executed on April 5, 2005, which agreement the parties hereby reaffirm, and (2) this First Amendment to Agreement.

V. <u>TERM</u>

This Amendment shall be effective January 31, 2006 and shall end no later than June 30, 2006.
