## **EXECUTIVE SUMMARY**

Sacramento County is a partner in the Sacramento Public Library Authority that provides library services and operates libraries in the County. The County is responsible for planning, constructing, and financing library facilities within the county's jurisdiction. Impact fees levied on new developments provide a portion of financing available for library construction. Projects proposed to be completed in the 2011-12 Fiscal Year Capital Budget include an "Operating Budget Impact" statement.

• <u>Rio Linda Library</u> — Rio Linda has no independent source of funding for library facilities. In 2000, the Board of Supervisors allocated \$1.2 million financing from the 2001 Tobacco Litigation Settlement-Capital Project Fund to finance the design and construction documents for the new Rio Linda library. On October 23, 2007, the Board of Supervisors approved an additional allocation of \$528,735 from interest earnings on the 2001 Tobacco Litigation Settlement bond funds. The Library Authority, in partnership with Sacramento County, is exploring the feasibility and cost of funding tenant improvements at the Rio Linda Elementary School as a medium-term (5-7 year) interim solution using existing allocated Tobacco Bond funding, due to insufficient funding available for a new facility that was estimated to have a cost of approximately \$15.8 million. Estimated Total Cost: \$1,728,735
