Program Impact:

For Fiscal Year 2012-13, the Chief Forensic Pathologist position has been funded in the Pathology/Path Support division, Fund Center 4611300. This change is the result of the Chief Forensic Pathologist spending 95% of their available hours providing direct caseload work, due to the overload of cases and shortage of staffing.

The elimination of the last Assistant Coroner position from the Administrative Division, combined with the movement of the Chief Forensic Pathologist position to the Pathology/Path Support Division, leaves only the Coroner as the lone Management level classification within Administration to direct, manage and supervise the daily activities of the Fiscal Services, Information Technology, Human Resources, Clerical Support units, Investigations, Morgue Operations and Pathology Support.

The unfunded amount is the result of a reduction in the following account:

Potential Impact on other Departments/Program Partners:

The result of having the Coroner as the only Management level position in the department, responsible for the direct supervision of daily line level activities, in multiple administrative units, leaves little time for the Coroner to assist families, media, criminal justice stakeholders and County Executive staff with constituent complaint issues. This reduction will result in a delay in responding to inquiries from those listed above.

2. Program Title: Pathology/Path Support (Fund Center 4611300)

Program Description:

Responsible for forensic services (autopsies) and forensic service support, outside revenue agreement contracted autopsy services including contracted forensic autopsy services for Amador and El Dorado Counties, decedent transportation, death scene response/investigation, body processing and release to mortuaries, body storage and release, evidence/personnel property collection and release, contracted University of California Davis Medical Center decedent transport services, contracted University of California Davis Medical School Department of Pathology resident training/autopsy support services.

These two accounts provide for Pathology/Morgue Supplies and various services provided by other organizations that are necessary for the daily operation of the morgue and conducting autopsies. They provide for safety equipment and protective apparel, specimen collection materials, Toxicology, Histology, Genetic testing and Radiology services.

The total Department budget need for FY 2012-13 for Services and Supplies is \$1,287,773. Of this amount, \$813,216 is for Mandatory Allocated Costs. This leaves \$474,557 of which \$237,900 is unfunded, a reduction of more than 50%. All possible effort will be made to reduce expenditures in the supply and service accounts to equal the required reductions. If the department is unable to make the necessary reductions in these accounts the result will be the department exhausting their funding for all Services and Supplies by mid-year (January 2013).
