#### Overview

Pursuant to Health and Safety Code Section 1442.5, the Sacramento County Board of Supervisors must conduct a public hearing on the elimination of and/or reductions in the level of medical services provided by the County for the County's medically indigent. The Board of Supervisors will consider the impact on the health care needs of the County's medically indigent and will accept public testimony, both oral and written.

#### Recommendations

Conduct a public hearing on the elimination of and/or or reductions in the level of medical services provided by the County for the County's medically indigent.

#### Measures/Evaluation

#### **Fiscal Impact**

The hearing will consider all the proposed elimination or reduction of positions and operating costs associated with the County's indigent health program. The total proposed reduction is \$5,040,237 in General Fund cost.

#### **BACKGROUND**

The federal Affordable Care Act (ACA) became effective January 1, 2014. Under that Act, most low income, childless adults, who previously relied on county indigent healthcare programs, became eligible for Medi-Cal coverage or are able to purchase individual health insurance coverage through the State's Health Benefits Exchange. Prior to January 1, 2012, the County was responsible for providing healthcare to approximately 25,000 people – approximately 11,000 in the Low Income Health Program (LIHP) and 14,000 in the County Medically Indigent Services Program (CMISP). Since the implementation of the ACA, all LIHP and most CMISP beneficiaries have been transitioned to Medi-Cal. As of April 1, there were a total of 42 people on CMISP and the Department of Human Assistance estimates that that population could rise to as much as 700, mostly with a Share of Cost.

At the same time, the State reduced the amount of Public Health Realignment funding provided to counties, effective January 1, 2014. Without the ACA, the County would have received approximately \$43 million in Public Health Realignment in FY 2013-14; with the implementation of the ACA mid-way through FY 2013-14, the County will receive approximately \$34.8 million. In FY 2014-15 we expect to receive approximately \$13.4 million from this source.

All of this has major implications for the Department of Health and Human Services (DHHS) and Health Medical Treatment Payments budgets. DHHS has prepared budget reductions to meet the reduced need for services in Primary Health Services and the reduction of Public Health Realignment.

#### **DISCUSSION**

This Beilenson Hearing has been scheduled, as part of Budget Hearings, to address the impact of these reductions on indigent healthcare. DHHS has prepared the attached Beilenson Notice of proposed budget reductions and/or eliminations. The Board will consider all the items contained on the attached list and may approve the proposed reductions and/or eliminations, in whole or in part, to eliminate and/or reduce the estimated shortfall of available resources. The proposed elimination or reduction of positions and operating costs associated with the County's indigent health program do not result in a reduction of services but a Public Hearing was deemed appropriate for purposes of transparency and public testimony.

#### **FINANCIAL ANALYSIS**

The hearing will consider all the proposed elimination or reduction of positions and operating costs associated with the County's indigent health program. The total proposed reduction is \$5,040237 in General Fund cost.

#### NATURE OF CHANGE

Reduce the County Medically Indigent Services Program (CMISP) Primary Care Clinic for the medically indigent.

#### STAFF REDUCTIONS

As part of the Fiscal Year 2014-15 base budget, Clinic services deleted the following vacant positions:

- 1.0 FTE Health Program Coordinator
- 2.0 FTE Medical Assistant Lv. 2
- 1.0 FTE Medical Transcriber Lv. 2
- 0.5 FTE Nurse Practitioner
- 3.5 FTE Office Assistant Lv. 2
- 1.0 FTE Physician 2
- 4.0 FTE Physician 3

In addition, Clinic services transferred the following to other programs:

- 1.0 FTE Administrative Services Officer I
- 1.0 FTE Registered Nurse Lv. 2

The proposed reductions will eliminate the following:

- 1.0 FTE Clerical Supervisor 2
- 1.0 FTE Human Services Program Planner, Range B (vacant)
- 7.5 FTE Medical Assistant Lv. 2
- 9.0 FTE Office Assistant Lv. 2 (2.0 vacant)
- 0.5 FTE Physician 3
- 1.0 FTE Senior Mental Health Counselor (vacant)

In addition, the following staff will be transferred to other programs:

#### **CONTRACT / OPERATING REDUCTIONS**

- Elimination of the UCD Transforming Education and Community Health (TEACH) residency program (\$112,118) This includes partial funding of \$112,118 for a clinical faculty preceptor. In addition to this faculty, there are several other faculty physicians who share preceptor duties, approximately six residents, 3 subspecialty faculty and several medical students. This program has provided primary care and limited specialty services to medically indigent patients. This program has been offered in collaboration with Sacramento County since 2005. It aims to reduce health disparities and increase the number of primary care physicians in medically underserved communities. County employees such as Medical Assistants, Office Assistants and administrative support would have to be added for this program to continue operating. This program has had longstanding service to CMISP beneficiaries and has recently begun to serve as part of the managed care Integrated Behavioral Health Medical Home.
- Reduce contracted service levels to <u>CARES (\$150,000)</u> providing primary care services to HIV/AIDS who qualify for CMISP. This is based on actual expenditures.
- Will reduce funding for after-hours medical advice line <u>FONEMED contract</u> (\$85,000)
- Other operational reductions, such as extra help and registry services, totaling \$288,143

#### PATIENT SERVICES AFFECTED

The proposed elimination of positions, contracts and operating expenses does not result in a reduction of services to CMISP enrollees. These reductions are consistent with a decrease in service volume due to transitions that started with early Medicaid expansion under the Low Income Health Program (LIHP).

Faculty and staff provide chronic diabetes management program. It will be modified and provided by county staff.

### BEILENSON NOTICE FISCAL YEAR 2014/15 STAKEHOLDER COMMUNICATION

#### NATURE OF CHANGE

The County Medi-Cal Managed Care Advisory Committee will be eliminated. The Medi-Cal Managed Care Advisory Committee provides local stakeholder input and advisement to the State Department of Health Care Services and to the Geographic Managed Care Health Plans. The committee is comprised of key stakeholders representing the following: advocates, clinics, health plans, hospital systems, pharmacy, physicians, physician groups, Public Health Advisory Board, and government representatives (State, County Board, DHHS, and DHA). The Welfare & Institutions Code 14089.07 establishes this committee as permissible, but not mandatory.

Other planning functions such as the Healthcare for the Homeless Co-Applicant Board and compliance activities will need to be absorbed.

#### PATIENT SERVICES AFFECTED

This does not directly impact services. This forum is utilized to bring all health care stakeholders involved in Medi-Cal Managed Care to the table in order to improve service delivery, enhance communication and ultimately influence outcomes.

As of April 1, 2014, there are 300,218 Medi-Cal Managed Care beneficiaries in Sacramento County. That number is expected to grow significantly due to the Affordable Care Act (ACA) and shifts into managed care.

No savings. Mitigation plan is under preparation which will result in an increase in staffing costs at the MHTC to address this need. Plan will ensure no disruptions in continuity of care upon discharge. The Department estimates additional costs of \$47,000 to implement the plan.
