The hearings will be held in the Sacramento County Administration Building, Board Chambers, 700 H Street, Room 1450, Sacramento, California. During the course of the hearings, the Sacramento County Board of Supervisors may continue items to other days and times.

On Wednesday, June 4, 2025, at 9:30 a.m. the Board of Supervisors will conduct hearings on the following subjects which may be taken in any order:

- Budget Recommendations of the County Executive
- Capital Improvement Plan
- Public Comment
- Deliberations/Board Approval of Recommended Budget

If necessary, the Board of Supervisors will continue hearings and deliberations to 9:30 a.m. on Thursday, June 5, 2025, and Friday, June 6, 2025.
