Applicants must submit their application using the address of their office located in Sacramento County, even if the organization's main office is outside of Sacramento.		
4	Does the restriction on vouchers including grocery gift cards to address food insecurity?	Gift cards are discouraged. However, if gift cards are part of the project's scope of services, they will not be restricted, provided the need for the gift card is documented and justified. Proof the client received the gift card will be required to receive reimbursement.		
5	If our organization has a budget deficit is that disqualifying?	No, but use the budget note section in the application to explain the deficit.		
6	What does 'physical presence' mean?	Applicants must have a physical address for your organization in the County.		
	Is fiscal agent required for community base organizations?	Applicants must be registered as a nonprofit organization OR have a fiscal sponsor to be eligible.		
7	Is there a match contribution that is required?	No match is required.		
	Do we need an LEA and do we need sponsor letters?	Applicants will need to provide proof of their <del>your f</del> iscal sponsor.		
8	Would Rotary qualify as a Sponsor Organization?	Yes, Rotary organziations can act as Fiscal Sponsors.

Applicants can include all of the projects the organization is producing for the year, as long as all of the projects are within the same category or apply for funding of one event.

30	Is the personnel detail needed on the budget form if the applicant is not requesting funding for project personnel?	The project budget should include all expenses to produce the project including personnel if applicable.
