NOTICE IS HEREBY GIVEN that the Sacramento County Board of Supervisors shall conduct public hearings on the Fiscal Year 2026-27 Approved Recommended Budget on Tuesday, September 8, 2026, at 9:30 a.m. or as soon thereafter as is practicable.

The hearings will be held in the Sacramento County Administration Building, Board Chambers, 700 H Street, Room 1450, Sacramento, California. During the course of the hearings, the Sacramento County Board of Supervisors may continue items to other days and times.

At the hearings, the Board will consider revisions to the Approved Recommended Budget proposed by the County Executive and may make other revisions to the Approved Recommended Budget the Board deems appropriate.

If necessary, the Board of Supervisors will continue hearings and deliberations to 9:30 a.m. on Wednesday, September 9, Thursday, September 10, 2026, and Friday, September 11, 2026.
